 inhibited him to Preference for the Sum therein which did not bear An-  
 nuallrent, and the ranking him fictitious brevis manū gave him no  
 Right. Had the Price of the common Debtors Lands been divided  
 the Sale among his Creditors ranked, the personal Inhibitor would  
 have forced the Judges posterior to his Inhibition to pay him  
 his Money which he might have employed upon Annuallrent as he thought  
 fit. But having lain by for the Space of Several Years from claiming  
 his Money, he could still get no more than his neat Sum, which he  
 no Application affecting the Lands or Rents. In the Heir Male was  
 able for the Annuallrent of the Heir Females Portion from the Term of  
 Payment. Stair Jbid. By the Civil Law Annuallrent is due for a  
 Because given ad sustinendam onera matrimonij and the Husband entertains  
 the Wife. And the Lord Stair Jbid says that a Husband was found obliged  
 the Annuallrent of his Wifes Tutor tho' the Tutor was never paid. But yet  
 was found that Annuallrent is not payable for a Tutor unless it be so provided  
 the Bond or Contract 20 Decemb. 1670 Carnegy of Baismachil contra  
 Durham assented by Dordeton. A Man having left a Legacy to his  
 Daughter payable at her Marriage, she was notwithstanding entitled to  
 the said Legacy before she married: being the Condition was in her own Power, and  
 was her to hasten her Marriage 25 June 1667 Jorgil contra Jorgil. When  
 a Father expelled his Children out of his Family to whom he had reserved  
 Bonds of Provision, the Annuallrent of the Provision was modified Ac-  
 cording to the nature of the said Bonds, and not according to the  
 Father admitted them in his Family 15 July 1687 Jorgil contra  
 Jorgil. And the said Bonds Annuallrent after his death  
 from the falling due let 2. Sept. 2. Nov. 4. 7. 9. The Civil Law makes  
 Debtors liable for Interest without Paction in all Contracts sine pro-  
 mora. Et unde by the bare Default of paying at the Term of Payment  
 32. §. 2. f. de usur. That is, sometimes after Payment is demanded in a  
 Court of Justice, sometimes after the Term of Payment is elapsed and  
 dies interpellat pro pensione l. 12. C. de contrah. & commul. sup. Tho' no Demand  
 was made by the Creditor. But in Contracts stricti juris that Law makes Inter-  
 est only by express Stipulation. By our Law Annuallrent is not ordinarily due  
 in either of these Cases without express Agreement till the Debtor be denounced to  
 the Court for non Payment. Thus Annuallrent was not found due without Paction  
 for borrowed Money, altho' it was lent by one to his Brother an old Man wanting  
 Children in hopes of succeeding to his Means, from which the Creditor was ob-  
 liged by the Brothers marrying a young Wife at Decemb. 1662 Logic contra  
 Logic. The King uses to pay Annuallrent for the Ballance of his Accounts  
 tho' he be not obliged thereto by Law M'enzie Observ. on let 20. Nov. 2. 3. 4.  
 The Course of Annuallrent once due, stops and ceases when the Debt is paid  
 or acquitted l. 49. §. 1. f. de deb. empti. or orderly consigned upon the Creditor  
 Cessat l. 1. §. 1. f. de Usur. l. 28. §. 1. f. de admum. et peric. tit. or by con-  
 signation upon another liquid Debt due by the Creditor to the Debtor.

The Civil Law allows Interest no further than that it equal the principal  
 Sum l. 27. §. 1. C. 29. C. de usur. But in Scotland Annuallrent runs till the prin-  
 cipal Sum be paid, tho' it should never so far exceed the principal 13. March
