 taken before the next term, the writ shewd will find himself obliged  
 to take out a new p<sup>re</sup>cept, where in the duties for the term then exp<sup>ir</sup>  
 must be super added; and so forth till his writ be taken and Regis<sup>tr</sup>  
 his writ upon p<sup>re</sup>cept of the Chancery pass upon Petitions, must be given to  
 the Sheriff or other Judge ordinary of the Jurisdiction as Bailiffs. He

If the Judge ordinary refuse to suffer the writ, the Lord of the

Writ upon Application and Instruments taken against him of his Dis-  
 obedience, grant warrant to the Director of the Chancery, to give forth  
 a p<sup>re</sup>cept to any other person as Sheriff or Bailiff in that party, specially  
 Comptible to grant Instruments with power to Charge his own Clerk for  
 whom he is to be answerable. Whereupon the Director Expresseth a  
 p<sup>re</sup>cept with the same Expressions as in the first place: and  
 the Sheriff Constables will be Charged for what is due to the King. But  
 in regard his Majesty some times hath used prejudice by granting Com-  
 missions to his own persons as Sheriffs in that party, the Lord's Star  
 send to the Director of the Chancery for that effect Complain this  
 that before Expressing of the Commission Bailiffs be found, that he may
