

May so far terminate the plea as to Bar him who hath sworn from justifying contrary to his belief and persuasion, not hinder the other party to use afterwards what he hath proof by Oath, or Witnesses for justifying his Allegation.

Remedies against Commencing and Carrying on Actions or Suits out of Malice upon trifling pretences, and Disputing or opposing a just Claim for the sake of Cavilling. A Defendant who thinks the process groundless, or a pursuer against whom a sham Defence is offered, may Erase the other parties Oath of Calumny. Which Defese imports a Reflection upon his Frivility and Ingenerancy, as if he did Calumniate, that is, charge unjust pain to which he knows or believes not to be true. By the Ordinary Ambiguous words where in parties used to be Interrogated De Calumnia, Whether they have just Reason to affirm or deny such points, some thought they might safely depone for affirmatives, meaning that they had just Reason to pursue or Defend their own Interest, or that they know nothing of the truth thereof. Which doth not Answer the Nature of the Oath of Calumny, which is, that the cause he traverses is good and well. Et si quæretur, verum non sufficiat. There fore the words of session by an Act of Parliament, 3 June 1672 ordained, that where any party requires an Oath of Calumny upon any Allegance made, and found the Oath for him, he may require the party against whom the same is to be proved, to Depone, whether he does not know the same to be true; so that he should not put the Allegor to the necessity to prove the same, tho that of the party against whom any point of Allegance is to be proved, requires the Oath of Calumny of the proposer, he may Inquire, whether he knows that the thing he proposes is not true, so that it were Calumny, would for him to justify himself. But as my Lord Shaft. Lib. 4. Tit. 44. 517. observes, that Statute of session shall not get taken effect, and is further so clear words proper as the formula in the Act of Parliament (d. act 12. 5) therefore the Oath of Calumny may be fitly taken in these terms, Whether or not the Defendant believes that there is more probability for the truth of the point alleged, or against it. Which is sufficient to clear the proposer of the Allegance from Calumny. This Oath of Calumny, tho generally sought in initial Oaths, may be granted at any time before proof, or even after proof by Oath or Witnesses of no Import, but not after Conclusion of the Cause; tho even then an Oath of Verity may be required from the party against their Oath. 5. 19. Not only the parties, but also their Advocates may in many Occasions, be put to swear de Calumnia, tho in many Occasions, viz. whether they were Informed by their Clients
